Important Notes

- 1. For Divisions 3A, 5, 6, 7, 10 and Gateway (including income accounts): The balance remaining in your account must be at least \$6,000. And for Income Accounts, the balance remaining must also be sufficient to fund any remaining income payments in the current financial year.
- 2. For Division 1, 2, 3 and 15: One-off advice fees will be deducted from your Member Voluntary Account. If you don't have any existing funds in this account, this account will be negative after your advice fee deduction. Credited interest applies to this account, based on your investment option i.e. your negative balance will increase if investment earnings are positive. Any negative balance in your Member Voluntary Account will be deducted from your benefit when you leave your Division.
